The golf course at Chambersburg Country Club has been recognized as one of the finest and most challenging in Pennsylvania. The Club has hosted numerous state and local championships, including three USGA U.S. Open qualifying events. With six sets of tees, the course accommodates players of all skill levels. Golf facilities also include a nationally recognized, award-winning pro shop, putting green, spacious grass practice range and a dedicated short game area. The 25,000 square foot clubhouse offers excellent dining, a quaint pub with full service bar, versatile meeting and banquet rooms, and spacious men's and women's locker rooms and lounges. The Club's large, main and separate wading pools offer a great place for the whole family to enjoy a cool dip in the heat of summer, while a snack bar provides light meals and refreshments to the poolside crowd during the day. Racket sport enthusiasts enjoy some of the best playing conditions available in the area on our hard surface tennis courts and four pickleball courts, all lighted for evening play.

TENNIS

Our facility features one hard surface tennis court. All surfaces feature full lighting for nighttime play, with dedicated parking areas, and a historic clubhouse with changing facilities and an outdoor deck.

PICKLEBALL

The area's first dedicated outdoor pickleball courts were opened in the fall of 2013 and were resurfaced in 2021. Our facility features four dedicated pickleball courts, automatic pickleball machine and an active group of dedicated players. All surfaces feature full lighting for nighttime play, with dedicated parking areas.





SWIM PROGRAM

The area's leading swimming program is based at Chambersburg Country Club. Classes held for members include learning opportunities for those at the beginner level to experienced swimmers looking to compete nationally. Guided by our experienced team of coaches and guards, there is simply not a better place to learn!

OUTDOOR POOL



Details

Locker Rentals and Club or Cart Storage are annual charges. Refunds will not be given for cancellations. Fees and services will have sales tax added in accordance with state law and are subject to change per a decision by the Board of Governors. Cart Rates are exclusive of the PA sales tax rate of 6%. Weekdays are defined as Monday-Thursday. Weekends are defined as Friday, Saturday, Sunday & holidays.

- 1. To pay annual fees and any other charges in amounts fixed by the Board of Governors. I understand the preferred method of payment is via an automatic draft payment plan. I understand any fees are subject to change.
- 2. To abide by the By-Laws of the Club and such rules and regulations as may be prescribed by the Board of Governors and the Club Committees and as set forth in the member handbook. I understand rules, regulations, policies, and procedures are subject to change from time to time. These changes may be communicated via email, newsletters, or the club website and that it is my responsibility to keep abreast of such changes.
- 3. To pay finance charges of 1.5% (18% annual rate) and service charges, including, but not limited to, a \$20.00 late fee on any unpaid prior month balance not paid by the due date. I understand I have the privilege of charging expenses to my membership account and agree to pay those charges when a statement is issued either by mail to my address of record or made available via the internet after the close of each month and the balance shown on such statement is due and payable by the 15th of the month in which the statement is sent. I understand a valid credit card must be kept on file at the Club.

I further understand:

- 4. That my membership obligation is through June 30, 2026. I may resign my membership at that time with written notification to the Board of Governors by June 1st and will owe no further financial obligation to the Chambersburg Country Club after June 30th. I understand all club privileges cease on this date. Membership resignation requests will not be granted during the above term without Board approval for qualifying events.
- 5. If I do not notify the Board of Governors of my resignation, then I choose to continue my membership and I become financially obligated for the annual membership fees for the next membership billing year. I understand the membership billing year is from July 1st of one year through June 30th of the following year and that I am obligated for annual membership fees each year I am in active membership status on July 1st after my initial membership period has expired.

If my nomination is approved and if married, we agree any and all charges are our joint obligation. If I/we default in payment of any obligation, I/we may owe to the Chambersburg Country Club, I/we agree to pay all costs of collection, including reasonable attorney fees.
